## What is the purpose of this update?


## Description of this fund

The fund has a well-diversified portfolio that aims to provide growth, primarily through holding growth assets diversified with a lower allocation to lower-risk income assets. The fund aims to achieve medium to high returns, in exchange there will be larger movements up and down in the value of your investments. This fund is closed to new investors.

## What are the risks of investing?

Risk indicator for the AMP Growth Fund No. 2:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




## Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig received a return after fund charges were deducted of \$1,005.00 (that is 10.05% of his initial \$10,000). Craig also paid \$107.52 in other charges. This gives Craig a total return after tax of \$897.48 for the year.

#### **Currency hedging**

- fully hedging foreign currency exposure from International fixed interest and Australasian equities;
- hedging foreign currency exposure from International equities Developed markets at 50% hedged to New Zealand dollars; and
- not hedging foreign currency exposure from International equities Emerging markets.
- a range of foreign currency hedging may be used at the discretion of the Manager Other Direct infrastructure.

- On 24 May 2024 the phased transition was completed and AMP Wealth Management Limited (AMPWM) replaced Nikko Asset Management Limited (Nikko AM) as the underlying fund manager of the Nikko AM Balanced Fund. The fund performance in the table and graph relates to both AMPWM and Nikko AM.
- We have used a composite index to prepare the table and bar graph, as there was no market index available for some of the relevant assets. The composite index is calculated using the target investment mix weightings of the underlying market and peer group indices for the asset classes that the fund invests into. A composite index may be a less reliable indicator of performance than an appropriate market index. The composite index used in this fund update is not directly relevant for all of the underlying assets of this fund. In the table and bar graph, the return for the market index reflects no deduction for fund charges, trading expenses and tax, and the return for the peer group index reflects deductions for fund charges and trading expenses, but before tax.
